TERMS AND CONDITIONS OF SALE

IN THE MATTER OF M/S MASTERS APPARELS LTD (IN LIQN)

IN C.P.NO.358/11

- That the Moveable in question of the above said company will be sold by inviting sealed tenders on "AS IS WHERE IS AND WHATEVER THERE IS BASIS".
- 2 That the intending purchaser will be allowed inspection of articles/items in order to verify the present conditions etc.
- 3 That the tenders unaccompanied with a Demand Draft/Pay Order for the amount of earnest money in favour of the Official Liquidator shall not be accepted/considered.
- 4 That incomplete offers and containing terms and conditions of any kind are liable to be rejected. The sale will be subject to confirmation by the Hon'ble High Court of Delhi.
