- 1. Delhi Higher Judicial Service Main Examination (Descriptive) will be held on 9th August, 2014 in Delhi High Court premises.
- 2. If any of the aforesaid shortlisted candidates does not receive the admit card for Delhi Higher Judicial Service Main Examination (Descriptive) by 01.08.2014, he/she should collect the same personally from Joint Registrar (Vig.), Room No. 212, 2nd Floor, Administrative Block, Sher Shah Road, New Delhi 110 503 from 02.08.2014 to 08.08.2014 between 10.30 AM & 04.00 PM.
- 3. Although, in the advertisement issued for the aforesaid examination, 10 vacancies for General category have been notified, however, in view of the judgment of a Division Bench of Delhi High Court passed in WP (C) No. 983/2014 titled 'Nishant S. Diwan Vs. High Court of Delhi', the final selection would be made for 09 candidates only for General category.
- 4. In view of the decision of this Court directing for deletion of question no. 84, 34, 59 & 09 of Question Booklet Series A, B, C & D respectively which was duly notified vide Notice dated 05.05.2014, all the candidates have been awarded 02 marks in lieu of the aforesaid deleted question.

- 5. The final result of this Examination shall be subject to the outcome of WP(C) No. 256/2010 titled 'Keshav Kaushik vs. State (Govt. of NCT of Delhi) & Ors.', WP(C) No. 367/2010 titled 'Narender Kumar Chaudhry vs. State (Govt. of NCT Delhi) & Anr'. and Transfer Case (Civil) No. 77/2011 titled 'Surender Pal Singh Chauhan vs. State (Govt. of NCT, Delhi) & Ors.', WP(C) No. 256/2014 titled 'Dheeraj Mor vs. High Court of Delhi' and WP(C) No. 288/2014 titled 'Shatin Goyal vs. High Court of Delhi' pending in Supreme Court of India, and WP(C) No. 93/2011 titled 'Mukesh Kumar Maroria vs. High Court of Delhi & Anr.' pending in Delhi High Court.
- 6. The aforesaid shortlisted candidates are directed to send/submit attested copies of testimonials and original Certificates as stipulated in Sl. No. 12 and 13 of Part-I of Instructions appended to the Application Form within ten days of the declaration of result i.e. upto 09.06.2014.
